

**HANSEN LOVES SAN FRANCISCO SWEEPSTAKES  
OFFICIAL RULES  
INTERNET ACCESS REQUIRED TO ENTER**

1. NO PURCHASE NECESSARY.
2. This Sweepstakes is open and offered to legal residents of the 50 United States and the District of Columbia who are 18 years of age or older as of August 31, 2009. Employees and directors (and their respective IRS dependents, immediate family members [children, spouse, parents, siblings] and individuals residing in their same household) of Hansen Beverage Company (“Sponsor”) and its parent, subsidiaries and affiliated companies, advertising, promotion, or production agencies are not eligible to participate. Void where prohibited by law. By participating, entrants agree to these Official Rules and the decisions of the Sponsor, which are final and binding in all matters relating to this Sweepstakes. The Sweepstakes begins at 12:01 a.m. Pacific Time (“PST”) on August 31, 2009 and ends at 11:59 p.m. PST on October 4, 2009 (“Promotion Period”).
3. HOW TO ENTER & WIN: Visit [www.hansenslovessanfrancisco.com](http://www.hansenslovessanfrancisco.com) and follow the directions for completing and submitting the online Official Entry Form.

WEEKLY WINNERS. Each week a weekly winner will be selected from the photo submissions entered for the then current weekly contest (Monday through Sunday). There will be 4 weekly winners in total. Each week’s winner shall receive a cash prize of \$500 USD and will be entered into the Grand Prize contest for a cash prize of \$5,000. Only 1 photo submission per entrant per week will be accepted for judging. Any subsequent photo submission after entrant’s first photo submission in a week will be disqualified. Any attempt by any person to obtain more than the stated number of entries by using multiple/different e-mail accounts, or any other methods will void all of that person’s entries and that person will be disqualified. All weekly photo submissions must be received by Sunday 11:59 p.m. PST for the preceding week. Photo submissions will be rejected if the entry form is not fully completed and the entry form or photo is not received by the submission deadline. Digital photo submissions can be uploaded electronically as jpeg files. Digital photo submissions that do not meet technical requirements will be automatically rejected.

Participants must have taken the photo submitted for the Sweepstakes. The submitted photo must not have been previously published, exhibited publicly, or selected as a winner in any other contest. Only “amateur photographers” are eligible to participate in this Sweepstakes. For purposes of this Sweepstakes, an “amateur photographer” shall mean any person who has not earned \$1,000 USD or more in any year for photography of any kind.

Judging will be based upon the highest number of votes cast for each submission and the an independent panel of judges. The top 3 weekly submissions with the highest number of votes cast will be picked and then presented to an independent panel of 3 individuals

from an independent judging organization (the “panel”). The panel will then select the weekly winner from these top 3 weekly submissions. The panel’s decisions are final and binding in all weekly winner matters relating to this Sweepstakes. Judging will be completed and the weekly winner will be contacted by the end of each weekly contest. Limit of 1 prize per person/household. Sponsor will attempt to notify potential winners by telephone, mail and/or e-mail. If you have not been contacted, you should assume that your photo submission is not a winner.

**GRAND PRIZE WINNER.** One Grand Prize. The 4 weekly winners shall be entered into the grand prize contest and compete head to head for the chance to win the 1 grand prize of \$5,000 USD. Website visitors will have an opportunity from September 27, 2009 at 12:01 a.m. PST to October 4, 2009 11:59 p.m. PST to vote up to 3 times per day (i.e., a 24-hour period) for their favorite of the 4 weekly winning photo submissions. The winning weekly photo submission with the highest number of votes during the above-prescribed time will win the grand prize of \$5,000 USD. In the event of a tie in the number of votes received, an independent panel of 3 individuals from an independent judging organization (the “panel”) will select the photo with the highest score in creativity as the winner. Sponsor will attempt to notify potential grand prize winner by telephone, mail and/or e-mail. If you have not been contacted, you should assume that your photo submission is not a winner.
